YEAR 9 BRIARS RESIDENTIAL (15th—19th JULY 2024)

We are looking to take a group of Year 9 pupils to the Briars in July 2024. The cost will be approximately £315, (this could go up or down slightly depending on final numbers). This includes full board except Monday lunch, transport to and from the Briars, a full programme run by the Briars team, and a day of teambuilding activities (including climbing wall) run by a company called Acclimbatize. The Briars is a residential centre in Crich, near Matlock. Many of you will already be familiar with the work done by the Briars team through either your Parish or the experience of older children. Places on the retreat are limited to 50 and will be allocated on a first come, first served basis, based on those pupils who bring their completed consent forms into school.

If you wish for your child to be considered, please return the attached consent form by Wednesday 12th July. As representatives of the school, I expect all pupils to behave to our usual high standards. Anyone whom we cannot trust to behave will not be included in the trip.

If your child is offered a place a £50.00 deposit will need to be paid by the 30th of September 2023 and the outstanding balance of approximately £265 to be paid by the 22nd of March **2024.** The deposit is not refundable.
